I have been on the NANOG PC for many years and was chair of the PC for four years. I have been on the OpenDaylight Board for approximately one year, in addition to other leadership positions.

I have been a member of the NANOG community for over 20 years. I have served on the NANOG PC for 10 or so years including 3+ years as PC chair. Among other experience, I am currently the chair of the OpenDaylight Technical Steering Committee (see http://www.opendaylight.org/project/governance/tsc) and as well as serving on the Board of Directors.

In addition to significant experience as a Board member for non-for profits, I have also been a member of the Internet engineering community for the last 25 years. I'll note here that I have also been in various leadership positions in the Internet standards community, including working group chair (several different working groups), Internet Architecture Board, and Internet Research Task Force (among others).

Brocade is a vendor of Internet equipment. However, in my role as CTO I have wide latitude. In my role as Director of the Advanced Network Technology Center at the University of Oregon, we field various operational projects such as routeviews (www.routeviews.org), which is a key tool used by both operators and researchers who study BGP.

The key point here is that understanding complexity and the trends that cause it are of great importance to the operational community.

Personal objectives if elected: Grow NANOG both financially but also in terms of diversity of participants. In addition, it has always been my assertion that we need to attract and educate the next generation of operators; this is a primary objective.

Finally, NANOG needs to attract a younger generation. I have been concerned about the aging population going back to the early 2000s so this is (should be) a key focus. In particular, in order to have a vibrant community we need young people.

6) What advantages does and will NANOG gain by your contribution of resources, contacts or influence in the industry?

Primary advantages include experience and leadership ability, as well as a forward looking mentality. I have always pushed the leading edge of technologies (not only in the operational community, but also on the standards and Open Source fronts). In addition, I have deep knowledge of how the both the community and PC operate and have close connections to our members. As such I have a very good sense of our community and their needs.
